4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

OTHER TOXICITY: Large doses of bifenthrin ingested by laboratory animals produced signs of toxicity including convulsions, tremors and bloody nasal discharge. Long-term exposure causes neurotoxicity (tremors and impaired gait) in the early exposure in animal studies, but tremors disappears with continued exposure. Bifenthrin caused damage to the central nervous system through single and prolonged or repeated exposure.
